RE: 2025 USTA Georgia Junior Team Tennis State Championships

Congratulations on your team's advancement to the 2025 USTA Georgia Junior Team Tennis State Championships, to be held July 18 – July 20, in Macon, Georgia!

Outlined below is important tournament registration information along with several forms that need to be completed and returned to your Local League Coordinator for review and approval.

Eligibility: 10U: A team must have a minimum of four (4) eligible players. To meet this minimum, one eligible boy and/or girl substitute player may be added from the same local season. All players must have a minimum history of 2 team matches played, which may include one default, recorded in TennisLink. All players must be age eligible through August 31, 2025.

12U – 18U: A team must have a minimum of 3 eligible boys and 3 eligible girls. To meet this minimum, one eligible boy and/or girl substitute player may be added from the same local season. All players must have a minimum history of 2 team matches played, which may include one default, recorded in TennisLink. All players must be age eligible through August 31, 2025.

Fees: Team registration must be submitted online through TennisLink by **Wednesday, July 2nd**. This is a one payment per team registration at \$40 plus TennisLink processing fee per player. Example: 10 players would be a \$400 entry fee plus TennisLink processing fee payable with one credit card in one transaction.

Team Deposit: Team deposit will be held by the credit card submitted for team registration and may be charged if any of the following occurs: 1) a team withdraws July 4th or after, 2) a team captain/representative does not attend the mandatory captain's Zoom call, or 3) a team defaults an entire match. Once a team is registered in the TennisLink Championship module there are no refunds. The deposit held is \$300 + TennisLink processing fees.

Team Registration Packet: The following required documentation must be submitted to your Local League Coordinator for approval:

- 1) Team Profile
- 2) Copy of Team Roster printed from TennisLink showing number of matches played
- 3) Change in Roster form, if applicable
- 4) Change in Captain form, if applicable

All forms must be completely filled out to be accepted.





Consent & Waiver Forms: A signed Waiver and Consent Form is required for every player participating in the championship. Here is the link: <https://form.jotform.com/240804052763149>. The link for this form will also be available on the website.

Captain Zoom Calls: A team representative must attend the mandatory captain's Zoom call on Wednesday, July 16th at 7:00pm. Call number and agenda will be sent out the week prior.

Match Times: Tentative match times and sites will be posted on the USTA Georgia website at <https://ustageorgia.com/juniors/jtt-championships/> no later than Friday, July 11th. If any changes are made to the tentative schedule the teams affected will be notified. Final (tentative) schedules will be included in the Captain's Folder you will receive at Captain's Registration.

Player/Captain Gifts: Every player and captain will receive an appreciation gift and tournament t-shirt. If a co-captain wishes to receive these items, a check for \$25 made payable to Georgia Tennis Association should be submitted with the registration packet.

Hotel Information: Hotels fill up quickly! Please go to the Macon Tennis Association website at www.maconareatennis.com for a list of tournament hotels. Ask for a special tournament rate.

Advancement: The Mary Hatfield Invitational will be held August 30th – September 1st in Rome, Georgia. This Invitational is replacing the Southern Section Championships. State Championship winners in the Beginner, Intermediate and Advanced divisions are eligible to advance to the Mary Hatfield Invitational. Discuss these dates with your team PRIOR to the State Championships. Your team may become eligible to compete in further championship events. Should your team qualify to advance to the Mary Hatfield Invitational, you will need to be prepared to make a commitment at the conclusion of the State Championships.

Match Format:	10U: 1 Gender Neutral Singles, 1 Gender Neutral Singles, 1 Gender Neutral Doubles 12U-18U: 1 Girl's Singles, 1 Boy's Singles; 1 Girl's Doubles, 1 Boy's Doubles; 1 Mixed Doubles
Format of Play:	Round Robin(s) or Un-flighted Draw. The use of multiple round robins or the use of un-flighted matches will require a playoff structure. See Championship Procedures for full details.
Play Begins:	Friday, July 18 th at 7:30 or 8:00 am
Play Ends:	Sunday, July 20 th
Playoffs:	Divisions that have two or more round robin flights or if an un-flighted draw is used, there will be a semi-finals and/or final. They will be scheduled for Sunday, July 20 th .
Awards:	Champion and Finalist teams will receive awards.
Surface	Hard Court
/Official Ball:	Penn (provided and handed out prior to each match)
Player Amenities:	State Championship T-shirt + Player Gift Player shaved ice voucher to be used one time Friday through Sunday on site.





How To Fill Out Your Team Profile Form

***Print your team roster from TennisLink while being logged in to find player and team information required to complete this form.**

Captain Contact Information - Name, cell phone number and email of person who will be responsible for team during entire tournament. If different from local league season captain, "Change of Captain" form must be attached. The new team captain must have completed the USTA Safe Play process and be added in TennisLink as a Team Coach/Captain.

Co-Captain Contact Information – Name, cell phone number and email of person who will be assisting captain and/or responsible for team in the event captain is not available. Must have completed the USTA Safe Play process.

League – Found on team roster advancing from local league season, Program/Local League Name: i.e. USTA Atlanta, CORTA, NEGTA, SCTA...

Team Number: Found on team roster advancing from local league season, TennisLink #7034.....

Age Division – Found on Team roster advancing from local league season under Flight Name/Rating Levels, i.e. 12U, 14U...(all players must be age eligible through August 31, 2025).

Level – Found on Team roster advancing from local league season under Flight Name/Rating Levels, i.e. Beginner (BEG), Intermediate (INT), Advanced (ADV)

NEW THIS YEAR: ALL age divisions will advance to the Mary Hatfield Junior Team Tennis Invitational.

Player's Name – Please print clearly and enter only eligible players from the original local league roster who will be playing at the State Championships. 10U – A minimum of four players is required to field a team. 12U-18U - A minimum of three girls and three boys is required to field a team. If a team is adding a substitute player to the State Championship roster to meet the minimum required number of players, the Substitute Player form should be attached.

Age – Enter player's age on August 31, 2025. All players must be age eligible through August 31, 2025. See team roster.

STEPS FOR CAPTAINS TO REGISTER TEAMS IN TENNISLINK FOR THE STATE CHAMPIONSHIPS

1. Go to tennislink.usta.com Junior Team Tennis or click [here](#)
2. In the right-hand column, under **Join Team Tennis**, find the heading **Championships**, click on **Register a Team**

2025 USTA Georgia Junior Team Tennis State Championship Change in Roster – Add a Substitute Player

Should a team roster drop below the minimum requirement to be able to advance to State, then one boy and/or one girl may be added from the same USTA Georgia Junior Team Tennis local league season to meet this requirement. All substitutions must be approved by the Local League Coordinator and State Coordinator and all player and team eligibility requirements must be met. Substitutes may not advance beyond the USTA Georgia State Championships with the team if the original local league roster is submitted for advancement to the Mary Hatfield Invitational.

If a team needs to add a player to their State Championship roster in order to meet the required minimum of 4 players (10U) or 3 boys and 3 girls (12U – 18U), this form needs to be completed and attached to the Team Profile Form. All substitutes must be approved by the Local League Coordinator and the State League Coordinator.

COACHING GUIDELINES

The following coaching guidelines will be in place for the 2025 USTA Georgia Junior Team Tennis State Championship:

- Only one person may be designated as the Coach during a team match and must be identified with a Coach badge.
- Coaches cannot be changed during any part of the dual match. If this rule is abused a team will lose their coaching badge for the remainder of the tournament.
- A Coach may coach the player(s) when the players change ends at the end of a game and may be done when the players change ends after the first game without delay.
- Coaching is not permitted during a tie-break game or tie-break in lieu of the third set.
- Coaches should remain outside the fence.
- Coaching should be positive reinforcement to your player and not against the opponent.
- A player is not allowed to be coached if the coaching is given by signals during play.
- Any violation of these Coaching policies may result in the suspension of the coaching privileges and point penalties.
