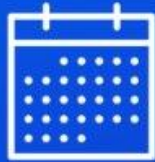

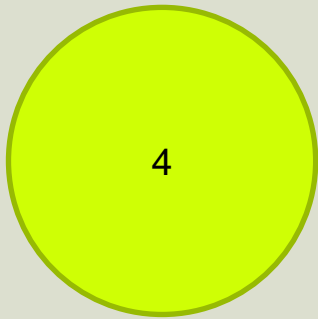

## Training Checklist

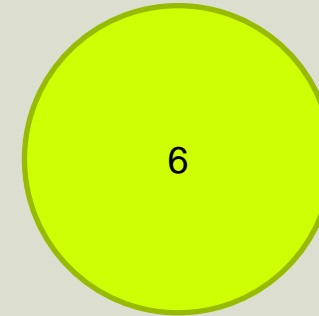
AS OF DECEMBER 15, 2022

The topics listed below are examples of various tasks and themes that a Prospect should gain experience in during their shadowing/training period. These are the same topics that a Prospect will be asked to either explain or demonstrate prior to final certification sign-off by the USTA Officiating Department.

When you feel like you have gained the necessary experience or knowledge in a topic, place a checkmark in the column on the right. This will help you to track your progress during your shadowing, training, or studying.

Each Prospect should be able to demonstrate or explain all areas found in the chart below:

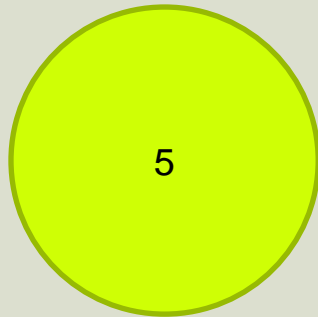
<b>Preparation</b>	The proper USTA uniform guidelines	
	Proper on-court equipment for a Roving Umpire	
<b>Court &amp; Equipment Set-Up</b>	Where singles sticks are placed and how to check the net	
	The process and reason for checking the balls	
<b>Pre-Match</b>	The pre-match conference	
<b>Timing</b>	The time between points, changeovers, sets and rest periods	
	The difference between Delay and a Time Violation	
<b>Medical Timeout Procedures</b>	Correct verbiage

<b>Professionalism</b>	How to handle a difficult situation (i.e. an irate parent)

Newly certified Officials will receive a welcome gift in the mail from the USTA Officiating Department.

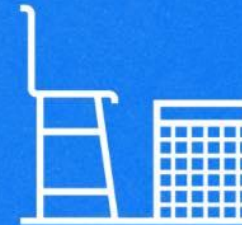
This gift includes on-court supplies, such as a tape measure, Friend at Court, flipping coin, pen, pocket notebook, as well as a uniform polo and hat.
